

We project that carbon emissions will decrease over the next five years to 322.8 tCO2e by 2026. This is a reduction of 17.2 %

The following environmental management measures and projects have been completed or implemented since the 2021 baseline and the measures will be in effect when performing the contract.

• We have joined the "Go Climate Positive" carbon certification programme and achieved the "Carbon Neutral" certificate, which attests that we have calculated our full Scope 1, 2 & 3 carbon footprint and have defined a carbon reduction plan aligned with the global goal to limit global warming to 1.5°C and offset our 2021 carbon footprint with Gold Standard carbon credits

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Investigate replacing vehicles due for renewal in next 2 years with electric vehicles
- Perform heating timer/thermostat audit of each premises
- Replace all lighting with LED lighting
- Engage top 5 suppliers by value to commit to Net Zero by 2050
- Educate employees on optimising fuel efficiency when driving
